BY-LAW NO. 2024 -

A By-law to amend By-law 2017-07, being a By-law for governing the calling, place and proceedings of meetings of Council, Task Forces and Committees of Council for the Township of The Archipelago

WHEREAS the Municipal Act, 2001, S.O. 2001, c 25, section 238 as amended, requires that every municipality shall pass a procedure bylaw for governing the calling, place and proceedings of meetings; and

WHEREAS on February 17th, 2017, Council of the Corporation of the Township of The Archipelago enacted By-law 2017-07, being a By-law for governing the calling, place and proceedings of meetings of Council, Task Forces and Committees of Council for the Township of The Archipelago; and

WHEREAS Council deems it expedient to amend By-law 2017-07;

NOW THEREFORE BE IN ENACTED as a By-law of the Council of the Corporation of the Township of The Archipelago as follows:

- 1. By-law 2017-07 is hereby amended as follows:
 - i) Section 1.0 DEFINITIONS is hereby amended by adding a new provision:
 - #26.0 "NOTICE OF MOTION" shall mean advance, written notice, given by a member and received by the Clerk, advising Council that a motion will be brought forward at a future meeting of Council.
 - ii) Addition of Section #29.0 NOTICE OF MOTION, as follows:

#29.0 NOTICE OF MOTION

- 29.1 All Notices of Motions shall:
 - a) be in writing;
 - b) include the name of the mover and seconder.
- 29.2 A Notice of Motion shall be submitted to the Clerk no later than 24 hours prior to the Council meeting at which it is to be introduced.
- 29.3 A Notice of Motion shall be read out by the mover or the Reeve.
- 29.4 A Notice of Motion that has been read out shall be received without comment or debate by any member.
- 29.5 Copies of the Notices of Motions that have been read out shall be distributed to Members at the first available opportunity.
- 29.6 Consideration of a motion, of which notice was given pursuant to this section, shall be in order at the next regular meeting or at a special meeting of Council called for that purpose.

Appendix "A"

- 29.7 Prior to Council's consideration of a motion of which notice has been given previously, a revised motion on the same subject, approved by both the mover and seconder, may be substituted for the original one contained in the Notice of Motion.
- 2. That this By-law shall come into force and take effect on the day of the final passing thereof.
